Dedicated Faucet Undersink Filter Systems

Physical Specifications:

- · Includes a head assembly with integral mounting bracket and bypass valve, and a single cartridge filter.
- Inlet and outlet plumbing connections are 1/4" Push-In.
- System maximum operating pressure of 125 psi (862 kPa) and operating temperature of 100°F (38°C).
- Filter cartridges incorporate carbon block media.
- System is NSF Standard 42 and 53 and/or CFR-21 compliant.
- Cartridges are sanitary in design, requiring no contact with the filter media during cartridge change-out.
- · Filter cartridges are ready to use.

*IMPORTANT: Do not use with water that is microbiologically unsafe or of unknown quality without adequate disinfection before or after the system. Systems certified for cyst reduction may be used on disinfected water that may contain filterable cysts.





This Warranty, together with any and all warranties implied by law, shall be limited to a duration of five (5) years from: 1) the date of purchase and/or installation 2) the date of purchase of NEW vehicle from dealer.

This Warranty does not apply to: (i) defects that result from abuse, misuse, alterations or damage not caused by CUNO, and (ii) damages that result from the failure to properly comply with the installation, maintenance, or cartridge change-out instructions.

IMPORTANT: To file a claim under this Warranty you must complete and mail the Warranty registration card supplied with this Product to CUNO at the address below within ten (10) days of original retail purchase.

THIS WARRANTY DOES NOT COVER, AND IS INTENDED TO EXCLUDE, ANY LIABILITY ON THE PART OF CUNO, WHETHER UNDER THIS WARRANTY OR UNDER ANY WARRANTY IMPLIED BY LAW, FOR ANY INDIRECT OR CONSEQUENTIAL DAMAGES FOR BREACH HEREOF OR THEREOF.
